BIOGRAPHY

VINCENT R. TOCCI has had an active career in public relations over the past 25 years. As a career officer in the United States Air Force, he held such positions as Deputy Director of Information for the North American Air Defense Command (NORAD), Director of Public Affairs for the Allied Forces in Southern Europe (NATO), in the Pentagon as Special Assistant for Southeast Asia in the Office of the Assistant Secretary of the Air Force Office of Public Affairs, and the Air Activities Media Briefer in Saigon during the Vietnam conflict.

His work has covered all fields of mass communications, from media relations to film making. He has been Head of the ACS Office of Public Relations for the past four years and has brought his extensive experience and expertise to bear on the problems of

communicating chemistry to the public.

He has bachelor's degrees in biology and in education and a master's degree in secondary education, all from Duquesne University. He has pursued doctoral studies in public administration from the University of Arizona and graduate studies in Public Relations Mass Communications from Boston University. He is a member of the Public Relations Society of America.
