Chemistry Olympiad

West Michigan ACS is pleased to offer the opportunity for local high school students to take the ACS Chemistry Olympiad qualifying exam during the month of March. Our event is being run in a very different format, this year. We are asking local teachers to host the exam in their own school buildings. Past years have simply not been successful due to multiple scheduling and transportation challenges. West Michigan ACS will provide the exam booklets to the teachers, and the teachers will simply need to hold the exam with their students during the month of March and return the exams to the section coordinators for scoring. Grand Valley State Univ. chemistry department is once again coordinating the exam. The top 10 student scores (limited to 2 from any one school) will be invited to GVSU in late April for the completion of the National Chemistry Olympiad Exam which consists of multiple parts include a wet-lab component. Sadly, due to security concerns, the United States will not be sending a team to the international event which is located in Pakistan this summer.
